**Cash Management**, *Dana Kelly, NASFAA*

To earn this credential, you will need to know the rules and procedures a participating institution must follow to request, maintain, authorize, disburse, deliver, use, and return Title IV funds. You will need to know how to maintain Title IV funds held by the school, manage excess cash, and handle Title IV credit balances, as well as the notifications to provide and the authorizations to collect. This will help you demonstrate the ability—through effective cash management—to effectively administer the Title IV programs, and to minimize the costs and risks of the programs for students, schools, and taxpayers.

**Need Analysis**, *Norma Robinson, Barry University & Joan Bailey, University of South Florida*

To earn this credential, you will need to know the underlying principles of Title IV need analysis leading to the determination of a student's expected family contribution (EFC), including the three regular formulas used to calculate the EFC and the qualifications for the Automatic Zero EFC and the Simplified Needs Test. You also will need to know how to recalculate the EFC for enrollment periods other than nine months and for summer periods of enrollment. This will enable you demonstrate the ability to ensure the use of accurate and appropriate EFC calculations, which directly affects the equitable distribution of financial aid funding.

**Professional Judgement**, *Kylie Gross, University of Tampa*

To earn this credential, you will need to know about the authority granted to the financial aid administrator to make certain adjustments when students and families are facing special circumstances. You will need to know the explicit and implicit guidelines for exercising discretion using professional judgment (PJ) in matters related to dependency status, need analysis, and student or parent Federal Direct Student Loan (Direct Loan) Program eligibility. This will help you demonstrate the ability to protect the integrity of the Title IV programs by ensuring your school's policies and procedures related to the exercise of PJ authority are reasonable and applied consistently, resulting in the equitable distribution of financial aid funding.

**Administrative Capability**, *Dana Kelly, NASFAA*

To earn this credential, you will need to be able to identify the measures of administrative capability by which a school is judged as being capable of adequately administering each Title IV program. You will need to know the standards defined in Title IV regulations, such as ensuring sufficient resources, resolving conflicting information, meeting all reporting requirements, and identifying potential fraud and abuse. This will help you demonstrate the ability to work with others at your institution to properly manage the Title IV aid programs and meet your school's obligation to educate and prepare students.

**Student Eligibility, Lakisha Sanders, Clayton State University/GASFAA**

To earn this credential, you will need to know the student eligibility requirements for receipt of federal financial aid. This will help you demonstrate the ability to protect the integrity of the Title IV programs by ensuring—prior to awarding or disbursement of funds—that your school’s students meet all relevant student-related and program-related eligibility requirements.

**R2T4, Katie Conrad, Florida International University**

To earn this credential, you will need to know how to handle a student’s Title IV funds when he withdraws from school before completing the payment period or period of enrollment. You will need to know the basic requirements for the return of Title IV funds (R2T4), whether and when to apply the requirements, how to determine the student’s withdrawal date, how to calculate the return of funds for each Title IV program, all applicable deadlines, and the rules for making post-withdrawal disbursements. This will help you demonstrate the ability to protect the integrity of the Title IV programs by ensuring your school promptly returns federal funds for which a withdrawn student no longer qualifies.

### **Cash Management Regulations Overview - David Bartnicki, US Dept. of Education**

This session will provide policy and operational guidance on the cash management requirements set out in 668 Subpart K. The session will include information about: institutions that partner with banks and servicers; making disbursements; notices; authorizations; the advance, HCM1, HCM2 and reimbursement payment methods; returning funds; and books and supplies.

### **Funding Florida's Future: The Role of Financial Aid in Achieving Florida's Degree Attainment Goal - Kimberly Lent, Florida College Access Network**

Labor economists predict that, by the year 2025, at least 60% of jobs in Florida will require a credential beyond a high school diploma. Currently, only 47% of adult Floridians hold such a credential. To ensure today's students are ready for these rapidly approaching economic realities, Florida College Access Network (FCAN) has adopted the goal of increasing Florida's degree attainment goal to 60% by the year 2025. Financial aid will be crucial to making this goal a reality for Florida's students. In this session, attendees will learn about the role federal and state financial aid plays for Florida's students. First, FCAN's team will present research evaluating state financial aid appropriations and distribution for the past ten years. Then, FCAN will review updates to state financial aid budgets coming out of the most recent legislative session, and how these updates will impact Florida's students.

### **Building And Implementing Year-round Training for the Financial Aid Office - Kristina Chavers, University of Central Florida**

In the fluid and every-changing climate of financial aid it is important to an office to stay abreast of changes in policies, documentation, and business practices. In order to stay well-informed and educated as an office The University of Central Florida implemented year-round financial aid training which encompasses federal and state legislative updates, business process reviews as well as policy and procedure overviews. This presentation provides insight and best practices for developing a year-round training program for Financial Aid Administrators as well as tips as to how to involve the office as a whole in the training process.

### **Building a Culture of Diverse Data Users Through Data Visualization - Dr. Resche Hines, Trivium BI**

This session demonstrates how Trivium BI partners with institutions transformed institutional data into interactive Power BI analytics reports to inform institutional decision-making. Trivium BI partners with departments across an institution to provide a holistic view of data trends and developed shared interactive reports which display data from multiple lenses and units of analysis. As a result, the reports have facilitated campus learning; specifically, the ability of stakeholders to contextualize understanding and comprehend crucial data patterns. This has in turn fostered an institutional data culture shift from merely asking questions to leveraging appropriate data and insight to identify opportunities for change.

### **A Little Nudge Goes a Long Way: Helping Students Help Themselves - Shannon Cross, Inceptia**

"Nudge" is all the rage right now, with its proven success in increasing FAFSA completions, decreasing summer melt, and improving retention rates. But its effects aren't just limited to sprawling national campaigns – you can make big changes with tiny nudges at your own campus!

If you're curious as to what nudging is all about and how it could potentially work for you, join us for this session to explore the why, how, and when of nudge theory. A case study from Indiana University will demonstrate how a simple letter nudged students toward better borrowing habits. We'll also discuss guidelines and ideas for utilizing nudge theory at your campus. Attendees will come away from this session with:

**Legs, Regs, and You** - Karen McCarthy, NASFAA

Wondering about the difference between legislation and regulation? How are each made, governed, and enforced? How do they impact the day-to-day work you do as a financial aid administrator? This session will provide a “101” on development and implementation of legislation and regulation, and how it pertains to you and your role!

**Helping Students Fund Their Roadmap to Success: Private Scholarships, Foundations and Financial Aid** - Bill Hoffman, Malaina Mote, Sharon Bayata, Earl Young

Federal, State and Institutional Financial Aid certainly form the bulk of financial aid for students, but did you know that more than \$10.8 billion is given out in Private Scholarships to students annually? In this session, you will meet three members of Florida’s Philanthropic Network. They will explain how their processes work, how donors shape the scholarship awarding process, when and how scholarship selection takes place, and how dialogue between “outside” scholarship providers and those of us “inside” the financial aid office can help improve student success. At least once per year, institutions must assess whether students are making SAP. This session will offer instruction on how to evaluate SAP in accordance with applicable laws and regulations in a clock hour environment. We will provide an explanation of key concepts as they relate to clock hour programs, such as qualitative and quantitative (pace) measurements, maximum time frame, warning and probation periods, appeals, and academic plans. Where appropriate, examples will be provided to help demonstrate the elements that a school is required to include in its SAP policy from a clock hour perspective.

**Preventing “Debt Relief” Scam Companies from Hurting Your Students** - Will Shaffner, Michael O’Grady, Financial Aid Services

“Debt Relief” companies routinely scam student borrowers into giving up their FSA ID, change their FSA contact information, create a power of attorney, and in some cases charge students hundreds of dollars and then pocket their monthly payments. Getting into one of the many student loan payment programs is of course free, but thousands of borrowers are scammed into paying for a new repayment program. Although there have been some prosecutions, these companies continue to proliferate. See what you can do to create awareness to protect your students.

**Sometimes We All Need a Whack on the Side of the Head** - Daniel Barkowitz, Valencia College

Are you stuck in a thorny situation and unsure how to work your way out of the thicket? Do you need a kick-start in your creativity? How do you stimulate creative thinking? In this session, we will be teaching you that creativity is a learned behavior, not an innate skill. Come learn how to be creative and find a new solution to your old problems.

**The Florida FAFSA Challenge: Inside Florida’s Efforts to Boost Statewide FAFSA Completion Rates** - Kathy McDonald, Florida College Access Network

About 60% of Florida students who complete a FAFSA are eligible for a Pell grant, making Florida the state with the 3rd highest proportion of Pell-eligible students. But every year, Floridians leave behind more than \$100 million in potential Pell grants because they fail to complete a FAFSA.

To help more students access the financial aid they could qualify for, Florida College Access Network (FCAN) launched the Florida FAFSA Challenge in 2015. This challenge encourages schools and communities to take on the goal of increasing their FAFSA completion rate by at least 5% over the previous year.

This session will discuss how the Florida FAFSA Challenge helped build partnerships between K-12 institutions and their higher ed partners, as well as the role that financial administrators can play in supporting the efforts to drive FAFSA completion in their communities.

**Overview of CampusNexus Student Financial Aid Automated Process** - Ruben Garcia, Campus Management Corporation

This session is an overview of CampusNexus Student Financial Aid automated processes that allow you to reduce manual processes increasing regulatory compliance. The overview will include originations, disbursements and awarding with automated functionality that is available. The overview will expose you to feature functionality that you can utilize.

**Driving Enrollment and Retention For High Achieving, Low Income Students** - Lenny Akins, SixUp

For many high achieving, low income students, money is often the single largest barrier to entering college or finishing a degree. And while federal financial aid is available, often times it is not enough to help a student attend a four year school full time, and continuously, to graduate on time. With the advent of technology, more and more companies are now able to assist these underserved students. This session will explore how alternative data combined with machine learning is expanding financial inclusion for these students with the hope of helping them earn a good education and achieve their full potential.
